### **Author Agreement**

Thank you for submitting your manuscript to *Harvard Papers in Botany* (“HPB”), a publication of the Harvard University Herbaria.

You, \_\_\_\_\_, and President and Fellows of Harvard College, on behalf of HPB, hereby agree as follows:

1. As author of the Article, you grant to President and Fellows of Harvard College, on behalf of HPB, the non-exclusive right to publish, reproduce or license others to reproduce the Article or any part thereof, alone or as part of an anthology or collection, on a royalty- free basis, in all forms and media whether now known or hereafter developed, throughout the world and in all languages.
2. Subject to Section 5 below, you warrant that:
  - a. The Article is your original work;
  - b. The Article has not been published elsewhere, whether in whole or part or in modified form, and is not currently being considered for publication by any other publication and will not be submitted for such review while under review by HPB;
  - c. The Article will appear in HPB before any version of the Article is published elsewhere;
  - d. Copyright to the Article or any exclusive rights to the Article have not been assigned to another party;
  - e. The Article contains no infringing or unlawful materials or materials that violate the rights of any individual, group or entity;
  - f. To the extent that copyright to any material in the Article is owned by one or more third parties, (i) written permission has been obtained from each such third party so that HPB may exercise all the rights granted in Section 1 above, (ii) such third party sources have been appropriately credited in the Article, and (iii) a copy of each permission will be made available to HPB upon request; and
  - g. If the Article was prepared jointly with other authors, you have informed each co-author of the terms of this Agreement and have directed him/her to the Editor of HPB if he/she has not yet received his/her own copy of this Agreement.
3. In addition to any rights retained by or granted to you in this Agreement, you retain the following rights, subject to Section 4 below:
  - a. The non-exclusive right to exercise all rights under copyright relating to the Article, in any medium, and to make the Article available, on a non-

commercial basis, in connection with your teaching, conference presentations, lectures, other works of authorship and professional activities, and to authorize others to do the same;

- b. All patent and trademark rights and rights to any process or procedure described in the Article; and
  - c. The right to prepare derivative works and to re-use parts of the Article in other works, on a non-commercial basis.
4. If you reproduce the Article or license others to reproduce the Article or any part thereof pursuant to the rights retained in Section 3 above, you assure, and you will require all licensees to assure, that HPB will be credited in all copies as follows:

6. HPB will provide you an electronic copy of the published Article within fourteen (14) days of its first publication at no charge, in a format such as the Portable Document Format (.pdf), which preserves final page layout, formatting and content of the published version. No technical restriction, such as security settings, will be imposed to prevent copying or printing of that copy. The published version may be used in the exercise of the rights and licenses referred to in the sections above.
7. If the Article was prepared by you jointly with one or more other authors, your signature below confirms that you are signing this Agreement on his/her or their behalf, as well as your own, and that you are authorized to do so.

Please indicate your acceptance of the terms of this Agreement by signing and dating both copies where indicated below and returning one copy to Harvard Papers in Botany, Managing Editor, Harvard University Herbaria, 22 Divinity Avenue, Cambridge, MA 02138. We suggest you retain the second copy for your records.
